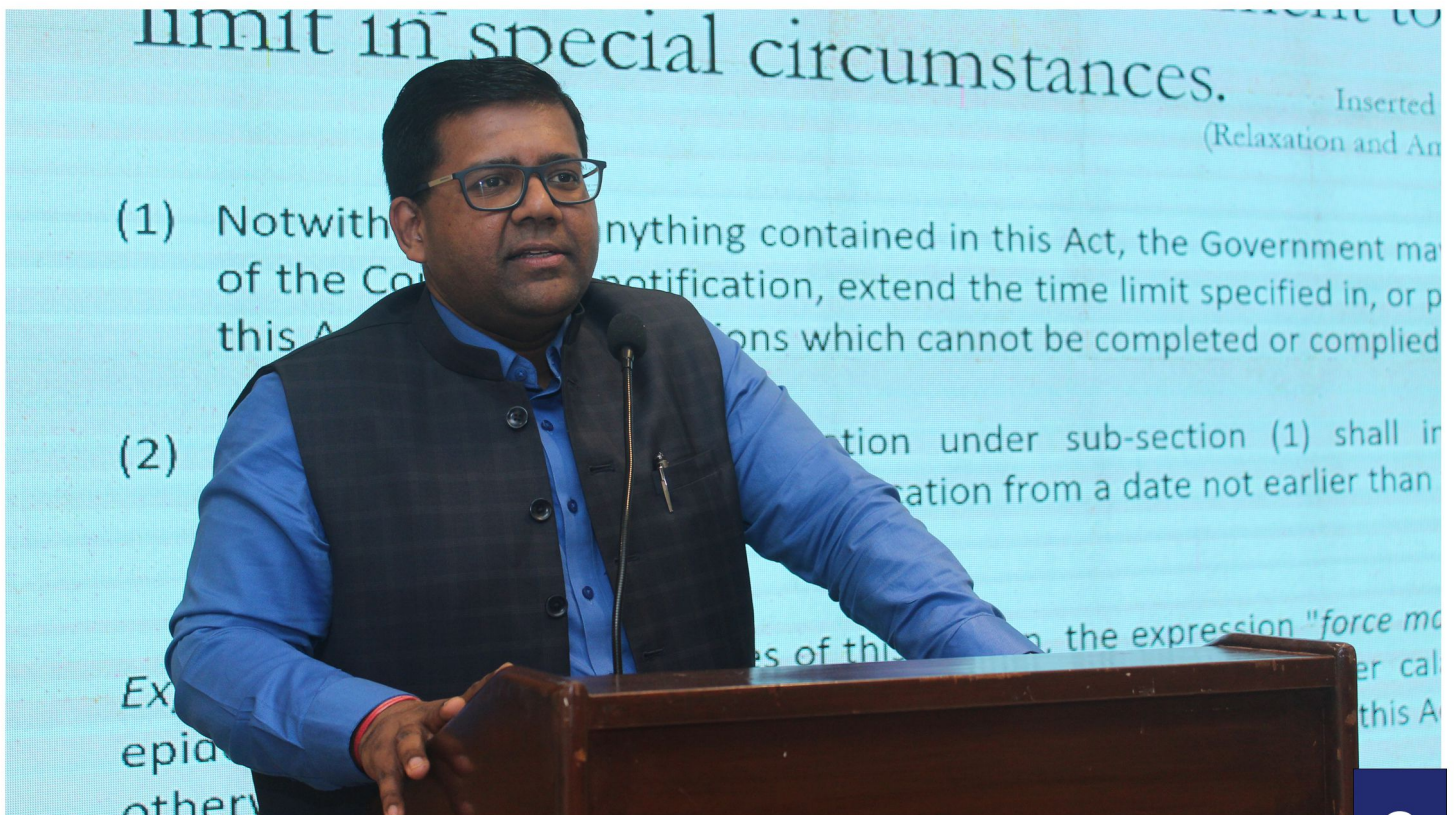
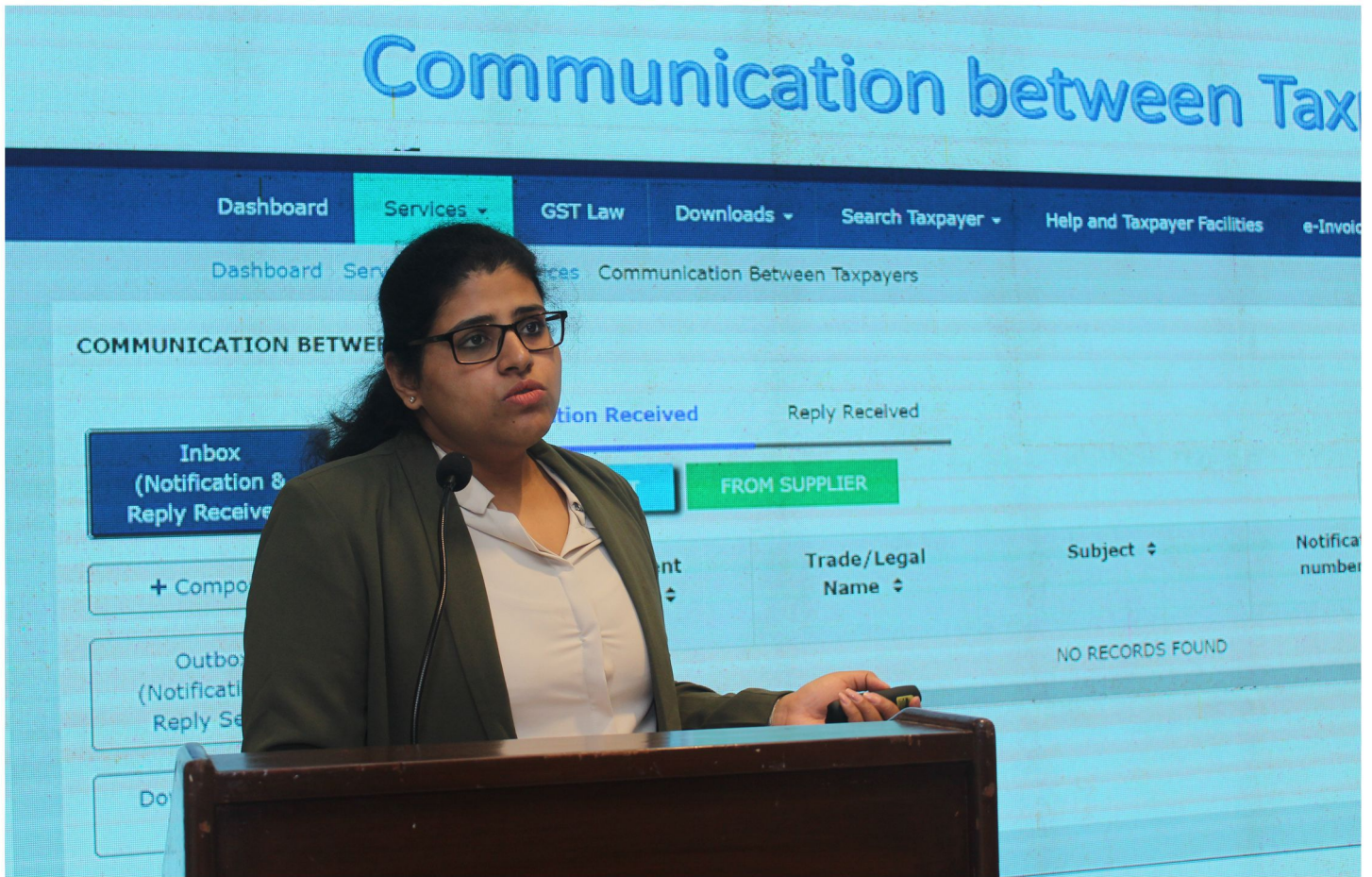
### ACTIVITIES UNDERTAKEN BY IPF FROM JANUARY TO MARCH 2024
